It's Tax Time and Insurance Enrollment Season

As part of the chapter leadership, tasks like filing your chapter's tax return, maintaining incorporated status with your state, and renewing your chapter insurance policy can creep up on you! Please contact DHI if you need guidance on the requirements of your chapter or if your chapter has lost its tax exemption status and you need guidance on how to reapply

DHI offers two insurance options at reasonable rates and this is your renewal season. These policies are intended to work together to be sure there are no gaps in coverage. We strongly encourage you and your fellow leaders to read the policy descriptions and coverage and purchase them to protect you and your chapter.

General Liability (\$77.00 US): Provides protection in the event of bodily injury or property damage to a third party due to alleged negligence. For example, if a member falls over an exposed extension cord because it was not properly secured or there is property damage to a third party's vehicle due to the wind blowing over a sign outside.

<u>Directors and Officers (\$400.00 US):</u> D&O insurance provides coverage for a variety of claims that allege a wrongful act attributable to the management or governance of an organization. Some of these wrongful acts could include: act, error, omission, misstatement or misleading statement, neglect or breach of duty.

The policy coverage is July 1–June 30 each year and must be renewed and paid for annually. DHI forwards 100 percent of the premiums to AH&T, the insurance broker for these policies. The enrollment forms and payment deadline was extended to June 14, however, late enrollments can always be processed. It will simply change your start date. 2018-19 Membership Year

Important updates regarding dues collection for the 2018-19 membership year were sent to all chapter leaders last month. If you did not receive an email, please contact Paige Horton to have it resent. As we noted, DHI will provide a process to support your individual chapter dues collection for active chapters. If you are not sure of your chapter status, please reach out to us for assistance. We will launch this process in Q4 of 2018 after the national dues collection concludes, so that we can capture all of your new members. We will confirm in advance what that will be for each chapter in Q4 2018 when we begin to work on execution.

The process will include DHI National invoicing, mailing, and collecting chapter dues and then reimbursing each chapter. We welcome chapter officers to include a letter to your members in the mailing, promoting your offerings and services over the next year. There will be a small administrative fee to cover our costs for the postage and envelopes. If your chapter would prefer to handle this process your own, we are fine with that; please let us know.

We will continue to support your efforts and goals throughout the year by sending new roster updates to active chapter leaders quarterly to be sure you have an active roster of new members at any given time. Chapter rosters can also be pulled 24/7 on our website and you may contact us to request one at any time.

DHI conNextions 2018 Wrap-Up

In May, Baltimore played host to over 1,500 door and hardware industry professionals who were looking to expand their business through education and networking. The show featured over 40 unique educational sessions, an unforgettably moving keynote address and over 100 leading manufacturers in the exhibit hall.

Attendees chose from dozens of conference sessions in four tracks - Access Control, Business Management, Technical and Codes. Some of the most heavily attended presentations included Accessibility Update, New Business Opportunities in Electronic Access Control, Business Ownership Transition, School Security Strategies, and International Building Code Roundtable. In addition to the conference sessions, a pre-conference workshop with speakers from the American Subcontractors Association was held, as were 10 quick Innovation Theater sessions on the tradeshow floor.

The keynote address was given by Michele Gay, founder of Safe & Sound Schools, who lost her daughter in the Sandy Hook shooting. She retold the emotional story of that day, Dec. 14, 2012, sharing with attendees how the day could have been different if only the right security measures had been in place. She closed with the message that our industry and our professionals have the power to go out and make changes to prevent such tragedies. As President Mike Gibson commented following Michele's speech, "I don't think there is anyone in this room who can say that what we do isn't important. We have the power to make a difference."

FDAIs Deliver DSSF Education to Healthcare Facilities

The Foundation offers a two-hour presentation to healthcare facilities outlining the requirements of NFPA 80 regarding maintenance and inspections of fire and egress doors. Upon completion, facility maintenance personnel will better understand these requirements, as well as how to properly assess and functionally test the condition of fire and egress doors, interpret inspection reports, and perform ongoing maintenance for continued compliance with code requirements. An add-on, two-hour presentation to the facility mechanics, focusing on maintenance and including a sample walk through of their facility is available. This program is delivered by a local Fire and Egress Door Assembly Inspector (FDAI) who is uniquely qualified and trained in the interrelation of doors, hardware, life safety, and security. DSSF has also made education available for purchase at a significant discount, exclusively to FDAIs, so they may generate their own local education engagements.
